Pensioner concessions can only be applied on presentation of a current Pensioner Concession Card, State Concession Card, Veteran's Card or a Seniors Card. (Pension concessions eligibility may differ between Local Governments)

The owner of a cat that has reached 6 months of age must ensure that the cat is **sterilised** by a veterinarian and microchipped, unless the cat is exempt from sterilisation or microchipping.

Fostering Rescue Cats

A cat that is in the custody of any of the following is exempt from registration:

- Cat Welfare Society Inc, trading as 'Cat Haven"; or
- Royal Society for the Prevention of Cruelty to Animals (RSPCA) WA Inc; or
- A cat management facility; or
- A veterinary clinic or veterinary hospital

A cat that is in foster care for less than 12 weeks is exempt from registration, if it has been placed into care by either the Cat Haven, the RSPCA WA or by SAFE (Saving Animals From Euthanasia).

Identification of Cats

The owner of a cat must make sure that their cat is identified. A cat will be taken to be identified when:

- a) The cat has a microchip implanted in its body, linked to the name, current address and phone number of the owner and:
- b) The cat wears a registration tag when in a public place.

Control of Cats.

The owner of a cat must take steps to ensure that their cat(s) do not cause a nuisance. This may include straying onto private property without permission. If your cat is found on property without consent it can be impounded.
