Pensioner concessions can only be applied on presentation of a current Pensioner Concession Card, State Concession Card, Veteran's Card or a Seniors Card. (Pension concessions eligibility may differ between Local Governments)

The fee payable for registration of a **Working dog** (a dog *bona fide* used in the droving or tending of stock) is 25% of the fee that would otherwise be payable. The declaration must be completed.

Sterilised fees will only apply on presentation of either of the following:

- Veterinary Surgeon's Certificate of Sterilisation; or
- Signed Statutory Declaration; or
- Shire officer sighting dog's ear tattoo and confirming sterilization.

There is a significant difference in the registration fees for sterilised and unsterilised dogs and you are urged to consider the long term financial benefits of having your dog sterilized. Pro rata refunds can be made where licensed dogs become sterilised Dog regulations 2013 R.19.

The fee payable for registration of a Declared Dangerous Dog, Restricted Breed Dog or Commercial Security Dog is \$50.00. Concessions do not apply to these and registration must be renewed annually.

Breeds are prescribed as restricted breeds for the definition of **dangerous dog (restricted breed)** in section 3(1)

(a) dogo Argentino; (b) fila Brasileiro;

(c) Japanese tosa; (d) American pit bull terrier;

(e) pit bull terrier; (f) perro de presa Canario or presa Canario; (g) any other breed of dog the importation of which is prohibited absolutely by the *Customs*

(Prohibited Imports) Regulations 1956 (Commonwealth).

The Shire requests that pet owners inform them immediately of any change of ownership, death of a pet or change of address.

Current registrations can be transferred between most local councils within Western Australia, and the registration period runs from 1 November through to 31 October each year (regardless of the date when the pet is actually registered).
