HOW TO PAY FOR YOUR CAT REGISTRATION

This Registration cannot be paid online.

Application forms must be processed prior to making payment.

Payment must be received within 7 working days following submission as registration is invalid without payment.

-  **In Person:** at the Shire office, Adam Street, Nannup. (Cash, cheque, money order, credit card or EFTPOS)
-  **Post:** Complete and return this form with a cheque or money order made payable to the Shire of Nannup. Or;

Pensioner concessions can only be applied on presentation of a current Pensioner Concession Card, State Concession Card, Veteran's Card or a Seniors Card. (Pension concessions eligibility may differ between Local Governments)

Important information for cat owners

- The registration year is 1 November to 31 October each year with the option of 1 year, 3 years or the lifetime of the cat.
- The owner, of a cat that has reached six (6) months of age, must ensure the cat is microchipped and sterilised by a veterinarian, unless the cat is exempt from microchipping and sterilisation.
- Under the Shire of Nannup Heath Local Law 2003, the maximum number of cats permitted to be kept on a property is three (3), this does not include kittens dependent on their mother (dispensation can be given to keep more than three (3) cats in some cases, subject to an **application to keep more than the prescribed number of cats** request submitted to the Shire and certain other conditions being met.
- Cats must at all times wear a current registration tag attached to their collar, this will assist in reuniting you with your cat should it become lost.
- The Shire must be informed immediately of any change in ownership, any change of address and the death of a cat(s).
- Definition of a Pensioner for concessional licensing purposes is as follows: Any person issued with a valid Pensioner Concession Card from Services Australia. Or a person issued both a Seniors Card and a Commonwealth Seniors Health Care Card.
NOTE: Only one concession can be claimed.
- Control of Cats:** Cat owners must ensure their cat(s) do not create a nuisance to others or the surrounding environment.
This may include straying onto private property without permission. If your cat is found on property without consent it can be impounded.
- Foster and Rescue Cats:** A cat that is in custody of any of the following is exempt from registration:
 - Cat Welfare Society Inc, trading as 'Cat Haven'; or
 - Royal Society for the Prevention of Cruelty to Animals (RSPCA) WA Inc; or
 - A cat management facility; or
 - A veterinary clinic or veterinary hospital
- A cat that is in foster care for less than twelve (12) weeks is exempt from registration, if it has been placed into care by either the Cat Haven, the RSPCA WA or by SAFE (Saving Animals from Euthanasia).
