



PRIMARY AND ANNUAL RETURN REGISTER

The Local Government (Administration) Regulations 1SSc, Regulation 29C(2)(d) and (5) requires the CEO to publish on the Shire’s website the name of each council member that lodged a primary or annual return for a financial year beginning on or after 1 July 2020 and the position of each Employee who lodged a primary return for a financial year beginning on or after 1 July 2020. Regulation 29D requires this information to remain on the website for not less than 5 years from when first published.
