Annie Crutchlow explained the Community Education Plan for January and February, and provided Phil Hewitt with the posters. Jenette Loud stated that the new campaign material will be available in time for the Community Education Plan renewal, and that there has not been any reports of volatile substance use reported in the SW since September, 2022, and that there is a new reporting system being integrated. Phil Hewitt asked whether the Nannup SJA would be involved in the learning of the rollout, and the answer was yes, as would the Shire of Nannup Ranger Services.

8 GENERAL BUSINESS

- Annie Crutchlow spoke to the Acknowledgement that was sent through to the Commissioner of Police, and tabled the letter of response in regards to our two LDAG committee members, and valued Nannup Police Officers, Sergeant Grant Berry OIC and 1/C Constable Matthew Goldstone. Committee members agreed that this is a fantastic outcome.
- Annie Crutchlow stated that the Courtesy Speed Display Signs from WALGA Road Wise (Katherine Celenza) are now in the Shire of Nannup's depot, ready for installation, with the first one going on Brockman Highway near the Nannup Tank 7 Mountain Bike Park Trailhead.

OTHER BUSINESS - ROUND TABLE

- Annie Crutchlow stated that there is a Mental Health Expo on at Manjimup District High School on the 22nd of March, and that Kaye from Bridgetown LDAG / Blackwood Youth Action have requested a Nannup LDAG Stall.
- Cr. Vicki Hansen stated that she has seen the SafeTalk workshop EOI, and Cr. Cheryle Brown responded that they have good interest so far.
- Cr. Cheryle Brown stated there is a First Aid Course at the end of March for those interested, and that the Nannup CRC are happy to assist with the Family Fun Day Project management into the future.
- Phil Hewitt asked whether there would be any Nannup LDAG promotional material at the Nannup Music Festival. Annie Crutchlow responded that she will wear the LDAG merch when she is there in a working capacity on the Sunday.
- Jenette Loud will follow up with the Mental Health Commission regarding any input on Harm Minimisation at the Nannup Music Festival
- Sergeant Grant Berry OIC stated that the Nannup Police has been busy, with ongoing illicit drug use spiking an increase in Mental Health issues and Family & Domestic Violence cases in the past four weeks. The drugs seem to be mainly heroin and methamphetamines. Isolation seems to also be a big factor in the cases seen. Jenette Loud commented that there is not currently an AOD Prevention Plan for Nannup. Grant Berry also commented that with the new gun laws being introduced where people are required to pass a Mental Health check, they expect a rise in issues at licence renewal.
