I have visited the site and reviewed the submitted plans. The following comments are provided;

- The construction, fit-out and operation of the proposed food premises within the Shire of Nannup is required to comply with:
 - o Food Act 2008
 - o Food Regulations 2009
 - o Food Standards Australia New Zealand (FSANZ) Food Standards Code
 - o Australian Standard 4674:2004 Design, construction and fit-out of food premises
- The premise will have the capacity to seat up to 200 patrons, as such the building would be classified as a public building under the *Health (Public Buildings) Regulations 1992*. An *application to Construct, Extend or Alter a Public Building* will need to be submitted with the building application.
- If amplified music is proposed for the premise, a Noise Management Plan may be required.
- If a licence to sell alcohol is to be sought under the *Liquor Control Act 1988*, applications for a Section 39 and 40 will be required.
