The North Nannup Volunteer Bush Fire Brigade (NNVBFB) for the past five years has engaged in discussions with Shire officers in regards to the acquisition of an additional single bay fire shed to house an extra emergency services appliance, to accommodate the increasing memberships and enhance the brigade's abilities to support the community in the event of a bushfire.

Following site inspections with members of the NNVBFB in consultation with Shire officers, the existing site of the NNVBFB located at 74 Dean, Nannup is not a suitable site for an additional single bay fire shed. The current building includes problematic restrictions to construction or extension. These restrictions include the location of underground utilities within the location of the proposed shed build, furthermore part of the site would require the rezoning of the road reserve.

Further discussions have led to the proposal of relocating the brigade, with the vision of a complete new shed build and design that would complement the brigade's future growth both in personnel and appliances.

Details of the proposal put forward by the NNVBFB are shown in Attachment 11.3.1.

COMMENT:

The Shire is committed to supporting volunteer workforce expansion and improving the wellbeing of the community by implementing appropriate measures and infrastructure to enhance brigade's abilities to continue to evolve and promote a safer community. The concept was discussed at the Bush Fire Advisory Committee on 3 May 2022 with positive outcomes and feedback from the committee.



The proposal of relocating the brigade includes:

- The allocation of half acre of land on Reserve 42358
- The acquisition of a Department of Fire and Emergency Services (DFES) funded three (3) bay Bush Fire Shed
- Two water tanks

Reserve 42358 is vested with the Shire of Nannup for the purpose of 'Public Recreation' as shown in Attachment 11.3.2 and is reserved as Parks and Recreation in Local Planning Scheme No.3. In Local Planning Scheme No.4 the land will be reserved as Public Open Space.

The applicant is requesting that an area approximately half an acre in size be set aside from Reserve 42358 for the use of the NNVBFB, and if required, be rezoned for this use.

The Shire administration suggests that it would be more appropriate for Council to request from the Department of Planning, Lands and Heritage (DPLH) that the purpose of the reserve be changed to 'Public Recreation and Emergency Services Site' which is consistent with the management order which is currently in place for the land used by the Darradup Volunteer Bush Fire Brigade. This would retain the land as Public Open Space for continued use by the community while also permitting the Shire to approve future works related to the NNVBFB.

It is recommended that Council support the request from the NNVBFB by submitting a request to DPLH to have the purpose of Reserve 42358 changed from 'Public Recreation' to 'Public Recreation and Emergency Services Site', to ensure positive volunteer interaction, pathways and future growth within the volunteer workforce which is an integral part of the Nannup community.

Annually the Shire of Nannup publishes a Notice made under the *Bushfire Act 1954, Section 33*. A copy of the Notice is included in a booklet distributed to all ratepayers. All owners and occupiers of land in the Shire of Nannup are required to carry out fire prevention work, to maintain access for fire fighting vehicles in accordance with the provision of this Notice.

The Notice was review at the Bush Fire Advisory Committee (BFAC) held 9 August 2022. Shire officers proposed some amendments to the existing Fuel Hazard Reduction and Firebreak Notice as follows:

- Title change to Bushfire Risk Compliance Notice
- Included Council Delegation BFA4 Alternative Fire Breaks where the Fire Control Officer (FCO) to sign the variation form before submission to the Shire
- Simple language
- Refine and align Bushfire Management Plan (BMP) compliance
- Moved Cockatoo Valley which has a BMP out of Special Conditions to Special Rural and highlighted the requirements of the BMP
- Remove duplication of information

All changes were accepted with the exception to include Council Delegation BFA4 alternative Fire Breaks. A request was made for FCOs and the Ranger to continue to closely liaise to ensure a joint understanding of compliance and acceptable alternative solutions.

COMMENT:

The *Bush Fires Act 1954* provides for local governments to regulate bush fire control measures by publishing an annual bush fire notice applicable to its district. The purpose is to direct property owners and occupiers to what must be done on their land to reduce fire risk. Property owners and occupiers within Shire of Nannup have a statutory obligation to comply with the requirements set out in the annual bush fire notice. Failure to comply can result in infringements or prosecution proceedings against the owner and/or occupier of the land. The



Shire can carry out work on non-compliant land and the costs are recoverable by the local government in the same manner as rates.

s.33. (1) give notice in writing to an owner or occupier of land situate within the district of the local government or shall give notice to all owners or occupiers of land in its district by publishing a notice in the Government Gazette and in a newspaper circulating in the area

s.33.(2) A notice in writing under subsection (1) may be given to an owner or occupier of land by posting it to him at his last postal address known to the local government and may be given to an owner of land by posting it to him at the address shown in the rate record kept by the local government pursuant to the Local Government Act 1995, as his address for the service of rate notices.

	Annual General Meeting Minutes

On 9 August 2022 the Bush Fire Advisory Committee (BFAC) Annual General Meeting was held. The committee recommended the appointment of Chief, Deputy Chiefs and Brigade Bush Fire Control Officers. Also, recommend Presiding Member and Deputy Presiding Member of the Shire of Nannup Bush Fire Advisory Committee.

A Bush Fire Control Officer is required as part of a volunteer bushfire brigade functions and the Shire of Nannup fire and emergency administration.

COMMENT:

The Bush Fire Advisory Committee Annual General Meeting carried the following motions:

The Shire of Nannup has a Community Emergency Services Officer (CESO) through a Memorandum of Understanding (MOU) with the Department of Fire and Emergency Services. A requirement of the MOU is to appoint the CESO as a Fire Control Officer.

The Shire of Nannup has a Ranger who is required to be authorised as a Bush Fire Control Officer in order to ensure compliance under Section 33 of the *Bush Fire Act 1954*. In addition, a Bush Fire Control Officer may have work carried out on the land to achieve compliance with the Notice. These costs are recoverable from the landowner.

A Bush Fire Control Officer is allowed access to complete property inspections under Section 14 of the *Bush Fire Act 1954.*

On 15 August 2022, the Shire President attended the fourth Industry and Community Development (ICD) subgroup meeting. The Hon. Dave Kelly Minister for Forestry presented the Industry and Community Development Programs (ICDP) Draft. The programs aim to drive further diversification of local economics and assist in identifying and securing sustainable job opportunities following the State Government's decision to end native forestry by 2023. The programs have been developed to support existing businesses to pivot and expand, to stimulate new industry investment, and to strengthen regional communities.

The \$30 million ICDP consists of the following contestable grants programs:

- 1. Small Business Development and Diversification (\$15 million)
- 2. Community Development Small Grants (\$5 million)
- 3. New Industry Development and Attraction (\$10 million)

Further information in relation to the program objectives and who should apply for the ICD Grant Program presented by the Minister for Forestry is as per Attachment 11.7.1. The ICD Grant Program Consultation Plan detail is as per Attachment 11.7.2.
