## **7. ZONE BUSINESS**

### **7.1 Cat Control Measures and Advocacy for Reforms to the Cat Act**

*Shire of Capel*

#### **RESOLUTION**

**Moved: Ms Tanya Gillet**

**Seconded: President Cr Michael Bennett**

**That the South West Country Zone request WALGA to support and advocate that the State Government progress remaining reforms of the *Cat Act 2011*.**

**CARRIED**

#### **BACKGROUND**

The Western Australian Government through the (then) Department of Local Government released a Discussion Paper (January 2011) titled *Proposal for Domestic Cat Control Legislation*. This consultation and

proposed reform process ultimately led to the *Cat Act 2011* (Cat Act) receiving Royal Assent on 1 November 2012.

The Cat Act fully commenced in 2013 and was introduced to:

- provide for the control and management of cats; and
- promote and encourage the responsible ownership of cats, and for related matters.

The Department of Local Government, Sport and Cultural Industries (DLGSC) commenced a statutory review of the *Cat Act 2011* and the *Dog Amendment Act 2013* in May 2019. The review undertaken by DLGSC was tabled in the WA Parliament by the Minister for Local Government on 27 November 2019.

Findings of the Review in relation to Cat Act included:

1. Registration of cats is strongly supported. The current three options for periods of registration should remain.
2. Registration periods for cats and dogs should be the same.
3. A central registration database for cats should be explored.
4. Feedback indicated that the wearing of collars and tags achieves the purpose of enabling a cat to be identified by rangers — including making it obvious that it is a domestic cat that has an owner. There is strong support for this to continue with no change.
5. Strong support from the public, local governments and industry exists for the practice of microchipping cats to continue.
6. Improvements could be made to the way microchip details are stored — this could be in either a national or State-based database.
7. Feedback indicated that education on the current requirements of microchipping, focusing on obligations of owners/breeders/rescues when a cat is transferred to a new owner and the need to keep information up-to-date, is necessary to achieve the desired outcomes of reuniting pets with their owners and the obligations of being a responsible cat owner.
8. There is strong support for cat numbers and confinement/curfews of cats to be implemented State-wide (in legislation) rather than through individual local laws — to provide consistency among local governments.
9. As a means of controlling cat numbers, there were multiple requests in the feedback received for the Cat Act to be brought into alignment with the Dog Act by placing greater restrictions on cat owners in relation to the number of cats that people can own.
10. The provisions in the Cat Act for cats to be sterilised should remain.
11. Feedback indicated that the age of cat sterilisation should be lowered, although further expert consultation on this will be needed.

Outcomes from the statutory review were:

- The *Dog Amendment (Stop Puppy Farming) Act 2021* received Royal Assent on 22 December 2021 with the aim to:
  - to amend the Dog Act 1976 to provide for matters relating to the sterilisation and breeding of dogs and the supply of dogs to and by relevant pet shop businesses; and
  - to amend the Dog Act 1976 and the Cat Act 2011 to provide for a centralised registration system; and
  - to make other amendments to the Dog Act 1976

No further amendments nor reforms of the Cat Act 2011 have occurred since.

## **SHIRE OF CAPEL NOTICE OF MOTION**

The Shire of Capel Ordinary Council Meeting on 27 July 2022 endorsed a Notice of Motion regarding Cat Control Measures and Advocacy for Reforms of the Cat Act.

The Motion also endorsed:

1. The CEO to arrange for a review of the Shire of Capel Cat Control Local Laws with consideration of the following matters:
  - a. Compulsory Cat Registration
  - b. Compulsory Cat Sterilisation
  - c. Compulsory Micro-chipping
  - d. Cat prohibited area and fauna protected buffer zones
  - e. Cat curfews – to be retained at their place of residence / registration.
  - f. Cat curfew enforcement system to be proposed.
2. For the Shire to develop and deliver a Responsible Cat Ownership Education Program to cover the following:
  - i. The devastating impact of domestic and feral cats on the birdlife and small native animals of Australia
  - ii. Construction of Cat Enclosures
  - iii. Cat proof fences
  - iv. Cat proof door locks
  - v. Cat collars with more than two bells
  - vi. Cat Bibs
  - vii. Cat Sterilisation
  - viii. Cat Microchipping
  - ix. Cat Trapping Information signage and notifications.
3. That the Shire write to DBCA requesting increased cat trapping on Shire Reserves.
4. That the Shire write to the Ministers for Local Government, the Environment, and others with related portfolios requesting progress on reforms to the Cat Act.
5. That the Shire submit a recommendation requesting support and advocacy for the State Government to progress reforms of the Cat Act, to be presented at the August 2022 South West WALGA zone meeting and (subject to endorsement) to be considered by WALGA State Council.

## **SHIRE OF CAPEL COMMENT**

- Any proposed changes to cat control measures should include public consultation.
- The Shire also hopes the State Government proceeds with reforms of the Cat Act, similar to recent reforms with the Dog Act and Animal Welfare regulations.
- The Shire of Capel has supported a review of current cat control measures and to look at initiatives to better protect native wildlife, along with an accompanying education campaign.
- Many local governments throughout the State have looked at similar reforms recently.
- Shire understands that many people in the community love cats, with reforms looking to find a balance between valued family pets and protecting our unique and in some cases, endangered native animals.

- 2. Call on the Minister for Environment to support regulatory arrangements administered by the Department of Water, Environment and Regulation that will allow new technologies that improve material recovery and recycling, including the processing of FOGO waste.**

### RESOLUTION

**That the South West Country Zone requests the WA Local Government Association (WALGA) to:**

- 1. Adopt a position that supports the utilisation of emerging waste processing technologies; and**
- 2. Advocate to the Minister for Environment to review the regulatory framework surrounding environmental approvals and operational obligations to allow new, alternative treatment processes and technologies that will reduce landfill reliance by improving resource recovery rates, including the processing of FOGO and un-separable, co-mingled material.**

**CARRIED**

### BACKGROUND

Renergi Pty Ltd has developed a technology to convert combustible waste into value-added products. Renergi's technology is new, utilising a low temperature pyrolysis process to recycle and reprocess waste into high-value commercial products such as biochar, bio-oil and wood vinegar. The process achieves CO<sub>2</sub> sequestration, resulting in a negative carbon emission.

The project makes a considerable contribution to the circular economy by diverting waste from landfill, optimising recycling and turning waste into energy and other beneficial products.

Financial support of \$3.9 million has been achieved from the Australian Renewable Energy Agency (ARENA) and \$2 million from the WA State Government. Private funding is also provided through a consortium of investors.

A prototype has been demonstrated at Curtin University's laboratory at Technology Park. The technology is to be pioneered at commercial-scale at the Shire of Collie landfill site, operating in conjunction with the Shire's waste services. Commencement of operation is expected in the first half of next calendar year.

## SHIRE OF COLLIE COMMENT

While the technology is capable of accepting all waste that is otherwise combustible, the terms of the approval issued by the Department of Water, Environment and Regulation (DWER) for the plant at Collie strictly limits the nature of waste that can be accepted and processed by the plant. That is, the plant can only accept forestry waste/plantation biomass or municipal solid waste (from the general household waste bin).

The inability to accept other waste, including food organics and garden organics (FOGO) limits the benefits that can be achieved and constrains the application of the new waste processing technology.

Approval for Renergi to accept all waste suited to the technology, including FOGO waste offers multiple benefits:

- Create flexibility in the way Council's manage kerbside waste collection, offering practical benefits to the community and operational cost savings for local government;
- Allow excess FOGO waste that cannot be processed by the to be recycled (such as the 25,000 tonnes of FOGO held by the Bunbury Harvey Regional Council);
- Avoid the need for contaminated FOGO (between 30-40%) to be redirected to landfill;
- Increase resource recovery rates;
- Increase recycling efficiency;
- Reduce overall waste to landfill;
- Generate commercial value products from waste;
- Utilise a process that has less environmental impact; and
- Optimise financial investments of the Federal and State Governments in the Renergi process, along with private investment.

Importantly, the new technology is advancing the Western Australia Waste Avoidance and Resource Recovery Strategy 2030 and will support the key objectives, targets and strategies.

- **Objective 1: Avoid:** Western Australians generate less waste
- **Objective 2: Recover:** Western Australians recover more value and resources from waste.
- **Objective 3: Protect:** Western Australians protect the environment by managing waste responsibly.

The proposal also aligns with 2030 Strategy five key principles (aligned with legislation and driving future decisions); *Shared responsibility and partnership-owning your impact; Innovation and growth; Better practice; Waste as a resource; Intergenerational equity.*

The recycling of waste as planned by Renergi is an initiative complimentary to other activities such as FOGO. It is important to remain flexible and responsive to incorporate emerging technologies to assist targets and benchmarks.

The plant at Collie is expected to demonstrate commercial scale waste processing. Anticipating this, support is sought from the local government sector to fully utilise the technology which can improve waste management practices and provide long-term waste solutions.

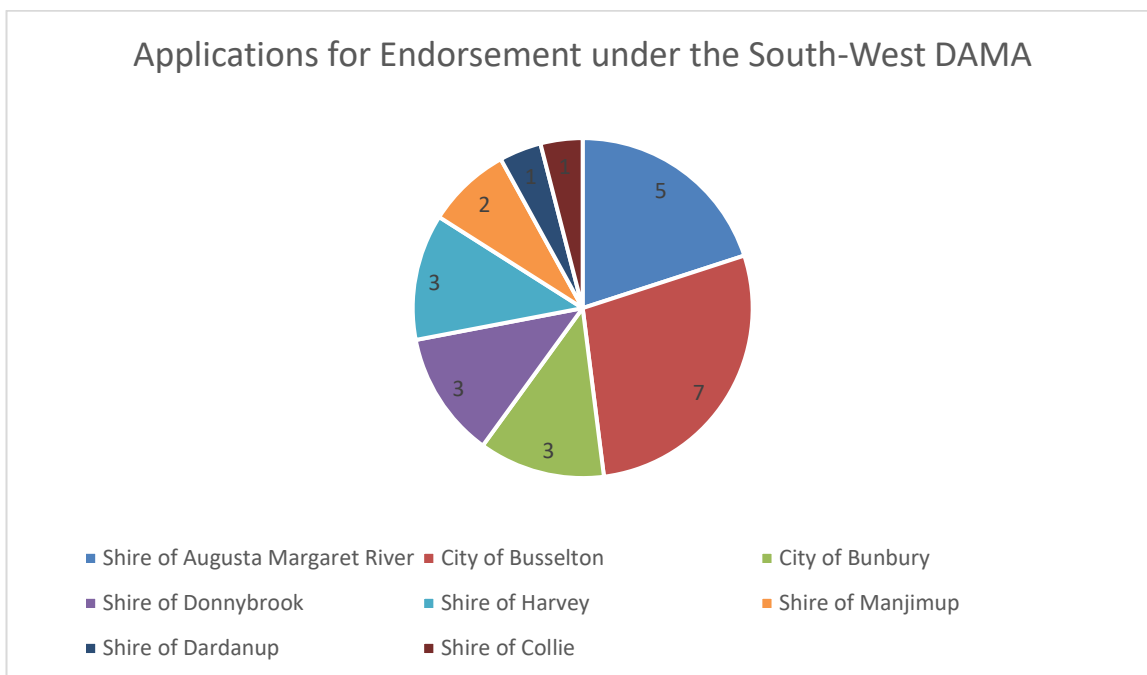
#### BACKGROUND

- Shire of Collie (1)



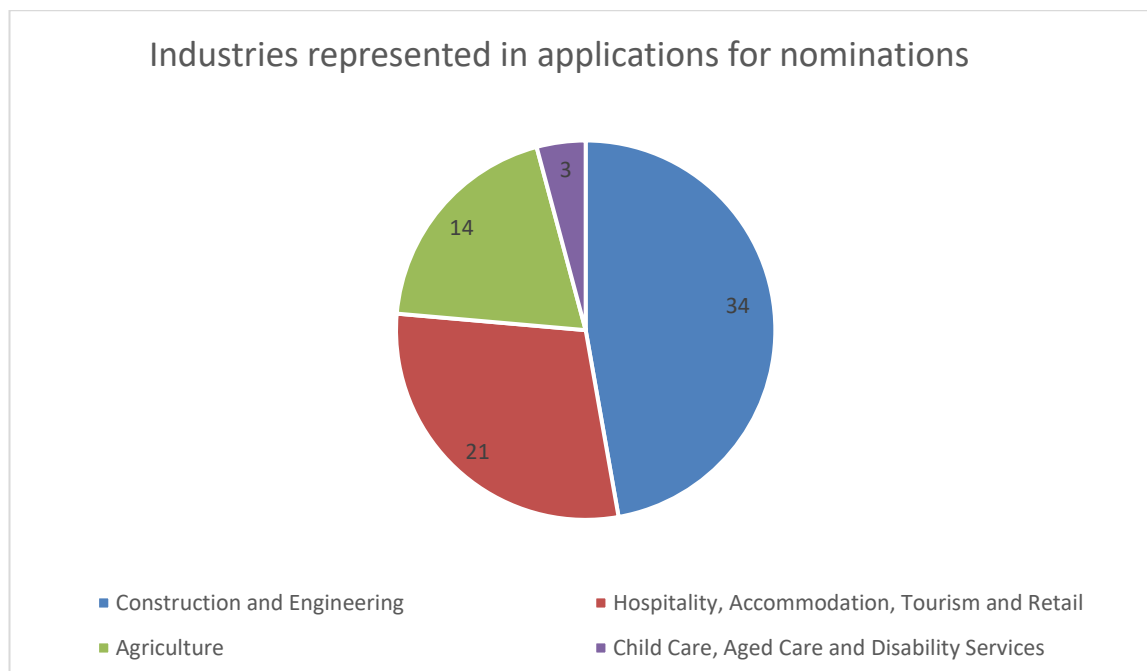

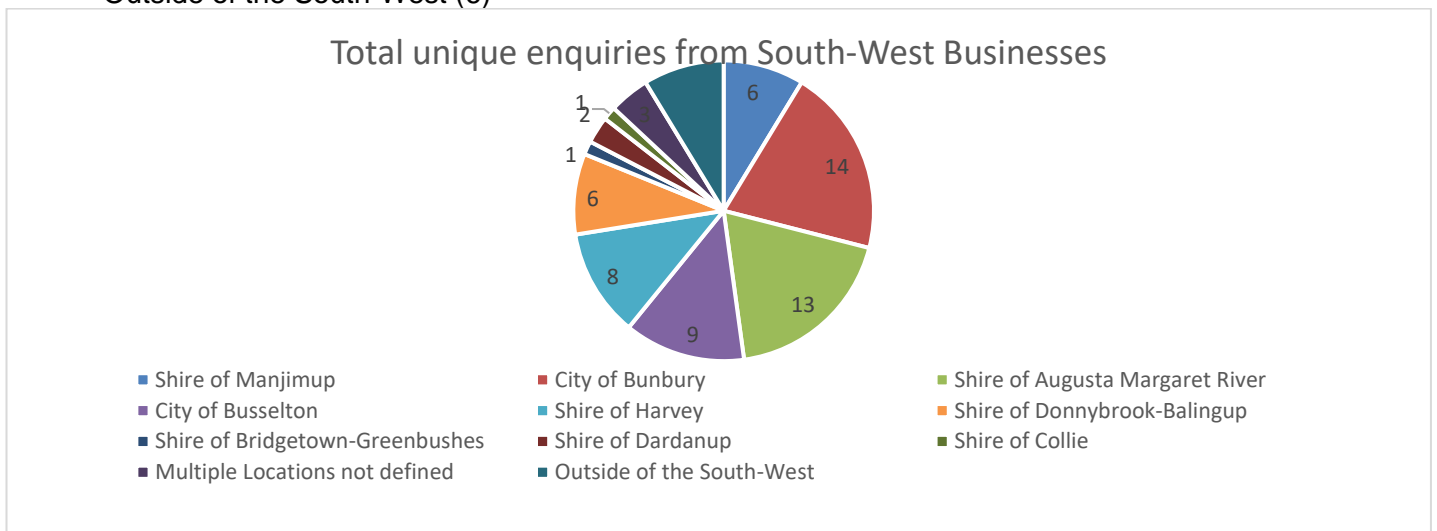

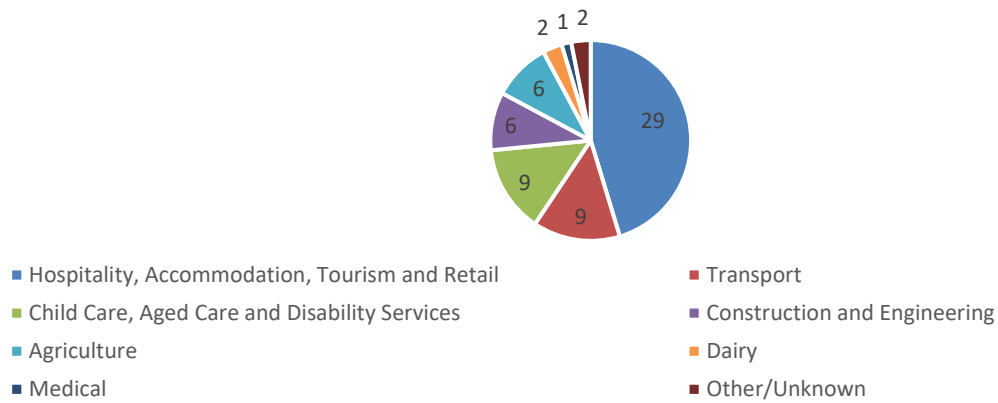

## **8. WALGA BUSINESS**

### **8.1 Review of the *Biosecurity and Agriculture Management Act 2007*: Consideration of WALGA Discussion Paper**

#### **RESOLUTION**

**Moved: President Cr Richard Walker**

**Seconded: President Cr Michael Bennett**

**That the Zone endorse the following recommendations:**

- 1. Strategic direction and regional priorities: The State Government develop a strategic framework that enables the prioritisation of biosecurity threats in geographically defined regions and sets targets for declared pest management.**
- 2. Agency responsibilities: The roles and responsibilities of each State Government department responsible for biosecurity management need to be a clearly defined and communicated, a formalised structure for different agencies to work together established, and increased investment made in declared pest management on State Government managed land.**
- 3. Declared Pest Rate and Recognised Biosecurity Groups: If the Declared Pest Rate and Recognised Biosecurity Groups (RBGs) are to continue to be key mechanisms for the management of widespread and established declared pests, changes are required to improve their operation and effectiveness to better support the concept of shared responsibility.**
- 4. Environmental biosecurity: A more balanced view of biosecurity that has a greater focus on environmental biosecurity is required, through increased recognition and management of pest species that have significant ecological impacts.**
- 5. Responses to incursions: Increased and more equitable distribution of funding is required to ensure each step of the biosecurity continuum is adequately resourced for all stakeholders, including Local Government.**
- 6. Management of declared pests in urban areas: Declared pest management in all urban areas requires support through an appropriate funding mechanism.**
- 7. Problematic non-declared pests: The process for the listing of declared pests needs to be timely and transparent to ensure that land managers, including Local Government, are not resourcing the control of an increasing number of problematic non-declared pest species.**
- 8. Sustainable funding model: A sustainable and equitable funding model is required to manage the increasing biosecurity management threat.**
- 9. Compliance and enforcement: The Department of Primary Industries and Regional Developments responsibility for compliance and enforcement needs to be adequately resourced and enacted.**
- 10. Monitoring, research and innovation: Strategic monitoring, use of new technologies and the establishment of data management systems are required to inform biosecurity investment decisions and support adaptive management.**
- 11. Community education and involvement: A stronger focus on community education to increase understanding and awareness will improve engagement with biosecurity management programs and assist with timely incursion responses**

**CARRIED**

#### **BACKGROUND**

The first 10-year [statutory review](#) of the [Biosecurity and Agriculture Management Act 2007](#) (BAM Act) is currently underway; this is a key opportunity for Local Government to influence the how post-border biosecurity is managed in Western Australia.

The [Independent Panel](#) undertaking the review, is using a three-stage engagement process:

- Stage 1 (closed) - open submissions and a survey to identify major themes and issues
- Stage 2 - stage 1 will 'provide the foundation for participatory processes to further explore themes and issues'
- Stage 3 - broader engagement to get feedback on the findings and potential solutions, expected to take place in late 2022/early 2023.

The Independent Panel is required to make its report, including any recommended amendments to the Act, to the Minister for Agriculture and Food by March 2023.

WALGA prepared a [Discussion Paper](#) to inform comment on the Review, which includes 11 key biosecurity themes and related recommendations reflecting issues raised by Local Government, and those identified in the [Auditor General's 2013 and 2020 Reports](#).

## **POLICY IMPLICATIONS**

WALGA's current Policy Position on Biosecurity, was endorsed in 2017 and is available in the [Advocacy Positions Manual](#) (Section 4.5).

## **COMMENT**

WALGA is seeking Zones' consideration of the recommendations included in the Discussion Paper to inform its submission to the Review on behalf of the sector and the development of an updated Biosecurity Advocacy Position. WALGA intends to put an updated Policy Position to the December State Council meeting. Local Governments are also strongly encouraged to make their own submissions to the review as appropriate in Stage 2 and 3.

#### 5.2 Proposed Advocacy Position on Management of Bush Fire Brigades

A. That the following Advocacy Position on Management of Bush Fire Brigades be endorsed.

##### Management of Bush Fire Brigades

1. Bush Fire Brigade volunteers play a critical role in helping to protect their local communities. Local knowledge and skills are integral to bushfire management in Western Australia.
2. Future management and funding of volunteer Bush Fire Brigades must:
  - a) Recognise the changing risk environment, including work health and safety requirements, and the increasing intensity and frequency of bushfires;
  - b) Take account of the differing circumstances of Bush Fire Brigade units and regional variations in bush firefighting approaches; and
  - c) Be adequately and equitably resourced through the Emergency Services Levy.
3. The State Government, through the Consolidated Emergency Services Act and/or other mechanism's must:
  - a) establish a clear framework to enable transfer of Bush Fire Brigades to the State Government if a Local Government decides to do so;
  - b) Consult on the process, timeline, and implications for transfer of responsibility for Bush Fire Brigades in accordance with 3(a) through the establishment of a working group comprising representatives of Local Government, Bush Fire Brigades, the

- Department of Local Government, Sport and Cultural Industries (DLGSC) and the Department of Fire and Emergency Services (DFES);
- c) Provide for mandatory and minimum training requirements and recognition of competency and prior learning for Bush Fire Brigade volunteers, supported by a fit-for-purpose and universally accessible training program, designed in consultation with Bush Fire Brigade representatives, Local Government and LGIS, and managed by DFES; and
  - d) Develop a co-designed suite of relevant management guidelines and materials to assist in the management of Bush Fire Brigades.
4. The State Government to consider the most appropriate operational model for State Government management of Bush Fire Brigades, which may include the establishment of an independent Rural Fire Service, as recommended in the 2016 Ferguson Report.

**B. That WALGA be advised that:**

1. None of the proposed models, including the Hybrid Model appear to address or achieve the issues of liability under the WHS Act or recommendations of the Ferguson Report.
2. The Zone recommends that WALGA engage fully with DFES and key stakeholders around a desired structure for volunteer BFB's with the key objective of maximising the capability of the service.
3. Key factors to be considered in that process should be seeking a sound position on the implications and responses to address WHS legislation including:
  - a. development of resources, capability and capacity
  - b. training
  - c. RPL process
  - d. consequential implications of the CES Act
4. That WALGA advocate for changes in the WHS Act that
  - a. Expands the definition of a dangerous operation to include Volunteer Emergency Services Workers. or
  - b. Expand the definitions section to include fire ground operations – means the performance of a function, or the exercise of a power, of a emergency services worker in circumstances where the performance of the function, or the exercise of the power, is not reasonably practicable without exposing a ESW to a serious risk to the ESW health or safety emanating from an immediate or imminent exposure to a hazard.
5. That WALGA advocate for protection for Authorised Officers similar to that provided to those that provide WHS services relating to work health and safety under 26A(1)(b)(iii) emergency services provided by police officers, or other emergency services personnel, in situations where there is a serious risk to the health or safety of any individual.
