5. SWEARING IN OF NEWLY ELECTED COUNCILLORS:

Following the Council Elections on Saturday, 16 October 2021, returned and newly elected Councillors were individually called upon to make the Declaration of Elected Member in the presence of Sergeant Al McNevin.

The following elected Councillors read aloud and signed the Declaration required under the Local Government Act 1995, which was witnessed by Sergeant Al McNevin, Officer in Charge Nannup Police.

6. ELECTION OF SHIRE PRESIDENT & DEPUTY SHIRE PRESIDENT:

Cr Tony Dean was elected unopposed to the position of Shire President for a period of two years.

Cr Dean read aloud and signed the Declaration required under section 2.29 of the Local Government Act 1995. Sergeant Al McNevin formally swore in Cr Dean as Shire President.

Cr Dean took up the positon of Shire President and assumed the Chair for the remainder of the meeting.

Shire President called for nominations for the positon of Deputy President. The following nominations were received in writing:

- 1. Cr Vicki Hansen
- 2. Cr Christopher Buckland

A secret ballot was held with the Shire President declaring Cr Vicki Hansen elected as Deputy Shire President for a period of two years (4 votes/3 votes).

Cr Hansen read aloud and signed the Declaration required under section 2.29 of the Local Government Act 1995. Sergeant Al McNevin formally swore in Cr Hansen as Deputy Shire President.

7. ELECTION OF COUNCILLORS TO VARIOUS ADVISORY COMMITTEES:

7.1 AUDIT ADVISORY COMMITTEE

Section 7.1A of the *Local Government Act 1995* states the following in respect to the appointment of an Audit Committee:-

- (1) A local government is to establish an audit committee of 3 or more persons to exercise the powers and discharge the duties conferred on it.
- (2) The members of the audit committee of a local government are to be appointed* by the local government and at least 3 of the members, and the majority of the members, are to be council members.
- * Absolute majority required.
- (3) A CEO is not to be a member of an audit committee and may not nominate a person to be a member of an audit committee or have a person to represent him or her as a member of an audit committee.
- (4) An employee is not to be a member of an audit committee.
